Continuing to thrive RURAL HEALTHCARE FOR THE FUTURE

We are here today because of the vision of the JRMC Board of Directors for what Jamestown healthcare should look like in the future. We all owe those on the board at the time the hospital was conceived and built and the current board who is carrying on that legacy and vision a thank you," states K.C. DeBoer, JRMC CEO during the Thrivin5 Anniversary Celebration held on July 28, 2016.

The evening highlighted growth, featured presentations from North Dakota senators and representatives and entertained over 400 guests. Mayor Katie Anderson declared the day "JRMC Recognition Day" and encouraged residents to recognize the positive impacts of JRMC in our community and to thank those who serve.

Since opening in July of 2011, JRMC has added specialty care including orthopedics, urology, foot and ankle surgery as well as advanced wound care. With anticipation, the addition of cancer care and obstetrics will follow in 2017. One of JRMC's greatest achievements is its designation as iVantage Health Analytics' Top 100 Critical Access Hospitals (CAHs) in the United States.

To qualify as a CAH and its reimbursement benefits, the Centers for Medicare and Medicaid Services (CMS) have criteria in place, including the number of inpatient rooms; length of stay parameters; the availability of emergency care 24 hours a day, 7 days a week; and being located in a rural area, at least 35 miles away from any other hospital or CAH. This last criterion spurred the recent scare over our status.

During a CMS checklist review of JRMC, the North Dakota State Hospital – which is only five miles from JRMC, not the necessary 35 – was determined to be a "hospital". Losing certification would change our reimbursement and could have resulted in a devastating revenue loss upwards of \$2 million.

JRMC is appreciative of Senator John Hoeven, Senator Heidi Heitkamp and Representative Kevin Cramer, the North Dakota Department of Health and the North Dakota Hospital Association for their immediate action on behalf of JRMC and those we serve. According to David Wright, CMS Director of the Survey and Certification Group, the criteria will be more clearly defined to specify "like hospitals." It will take time, but the rewritten criteria will ensure that this does not happen again.

The key to future rural healthcare delivery will be funding, quality, access to skilled professionals and continued political focus on the importance of critical access hospital care.

"When we talk quality of life, quality healthcare is so very, very important," says Hoeven. He along with Heitkamp and Cramer are working diligently to provide funding and good legislation for rural healthcare and Critical Access Hospitals.

About plans for JRMC, "If you're not innovating, you're evaporating," says Dennis Pozarnsky, JRMC Operating Board President. Expect that JRMC will continue to thrive.

Our fiscal year is in full swing starting with our July GOLF "fore" GOOD. This annual tournament is dedicated to those conquering cancer – with net proceeds totaling over \$26,000.

This event brings the Journey to Oncology campaign total to over \$400,000 raised for local cancer care.

JRMC is continuing this journey by moving into the planning and fundraising aspect of *Phase Two: Service Expansion*, with a focus on transforming shell space into what will be known as the JRMC Cancer Center.

Existing shell space will be finished to provide a convenient, on-campus location with sun-filled treatment rooms offering varying levels of privacy, space for consultation, education and support, services of credentialed nurses, leading-edge diagnostic imaging and biopsy equipment as well as healing art.

The campaign seeks to inspire donations that - combined with planned capital budgeting - will allow JRMC to complete and sustain a cancer center without incurring long-term debt.

"This service expansion is in line with our key belief at JRMC – to do what is best for the patient. We believe offering this service, in its own dedicated space, will do that for our community and patients," says K.C. DeBoer, JRMC CEO.

What aspect of working with Dr. Dean excites you the most?



JRMC Orthopedics specializes in joint issues, disease and the treatment of the musculoskeletal system. They handle everything from minor issues like a sprained ankle to complex procedures and surgeries such as a hip replacement. Some of the most common orthopedic procedures include fracture repair and ankle, knee, shoulder and hip replacements. They also perform a variety of arthroscopic procedures which allow them to visualize, diagnose and treat problems inside of a joint.




If the pain that you are dealing with is affecting your daily life significantly, then it is something that we should look at, and we can treat it. My hope is that patients will realize they don't have to live with daily pain, they can live like they did ten to 15 years ago without the pain, doing daily activities without altering their life. If you have any joint pain in the hands, neck, lower back, knees or hips, I encourage you to see me and discuss options. Joint pain most often does not get better on its own. Seeking care can really help your quality of life.

On a personal note, what's it like to come back to North Dakota after time away? Are you looking forward to any hobbies?

It's a nice change of pace and more relaxed. The need for orthopedic care in rural communities is so important; I am excited to be back here and bring access to that care with me. Watching and assisting with total joint repair is great. I also enjoy the inpatient care, and as their PA I can follow the patient from the start of their care throughout treatment and give them more of that one-on-one time throughout the whole process.



New experiences meet expectations communication key in delivery

here am I going to have this baby?" was always Marit Frick's fear about labor and delivery. Marit and her husband Zach Frick are rural farmers in Watford City, N.D. The closest hospital is an 85-mile drive. For first-time parents, the anticipation of getting to the hospital in time for delivery can be terrifying.

However, when Marit went into labor, she was in Carrington, N.D. She and her mother rushed to Jamestown Regional Medical Center. Although closer, it posed other unknowns. Frick realized she didn't have the comfort of her physician or birth plan.

"Am I going to have a good experience or be scared to death?" she questioned. Her fears were quickly alleviated after arriving in time and meeting Dr. Mandy Sorlie, the Sanford Health family physician on call for births at JRMC.

"Once she came in, introduced herself and addressed my fears, the experience changed for me. She was so positive and uplifting," says Frick. "Open communication is crucial in all areas of medicine, but especially in obstetrics. The birth of a baby is one of the most exciting times in our lives. I want to do everything I can to help moms and dads have the best experience possible," says Dr. Sorlie about meeting patients for the first time and every time for delivery.

"Many people don't know what to expect when they are having their first baby. They have either heard the horror stories or simply the highlights. Our goal at JRMC is to help our patients have a good experience and offer clear communication the whole way through so they know what to expect," says Emily Woodley, JRMC Family BirthPlace Manager.

The success is measured by the Hospital Consumer Assessment of Healthcare Providers and Systems (HCAPS) survey. JRMC Family BirthPlace recently scored the highest marks possible for 18 of 24 categories.

The HCAHPS survey is important because it allows hospitals to know their patient's perspectives of care, with public reporting of survey results. This promotes quality of care. It also creates hospital accountability by increasing transparency of survey results and patient quality of care. The survey is a national standard for collecting and publicly reporting information that compares hospitals locally, regionally and nationally.

In addition to physician and patient communication, having excellent communication between the physicians and nurses is another important factor in patient comfort during childbirth, and one Woodley says JRMC does well on according to survey results.

"The JRMC Family BirthPlace nurses and physicians who deliver babies have excellent communication because of close relationships. We get to know each other on a personal level increasing the trust we have and allowing us to support each other in the care provided to patients," says Woodley.

For the Fricks, all of these factors contributed to overcoming anxiety and having a great first birth experience with a hospital and physician they'd never seen before. "I had a great experience at JRMC and would not have changed anything. I want to have the rest of my babies here," smiles Marit.

he scene will forever be in my mind. In the fall of 1979, I received a phone call from my uncle, Paul Olson. I was living in New Salem with my husband, Curt. Uncle Paul gave me the dreaded news that my mother had lung cancer. I was only 26 years old and for the first time in my life, I felt an enormous sense of fear; not knowing if my mother would survive or not. When I saw her next,

I looked her in the eyes and the emotion rose suddenly in my throat. I swallowed hard and tried to fight off the tears and said in a breaking voice, "Mom, I love you." We both held each other tightly while I began to sob.

My mother had her surgery at Mayo Clinic in Rochester, Minn. Following her surgery, she required radiation treatments and

also chemotherapy. Then, in the spring of 1980, my father started to feel ill so he went to his physician who couldn't find anything wrong with him. With the encouragement of my mother, he went to Mayo Clinic for a complete physical exam. They found out he had advanced pan<mark>creatic cancer. Since it was too far</mark> advanced, all they could provide was hospice care.

The summer of 1980, I spent caring for both my mother and father. I became closer to my parents during that time. My father, Donald A. Olson passed away on July 23, 1980, at the age of 56 and my mother, Mildred E. Olson died on September 8, 1980, at the age of 54. The days that followed were the most difficult time in my life. As I attempted to maneuver life, I felt like my friends started to disappear. They appeared scared to see or talk to me; fearful of what to say to me due to the loss of my parents within six weeks of each other.

After my parents had died, I decided to dedicate my life to doing volunteer work while contributing part of my time to people who were affected by cancer. I began to take responsibility to honor my parents for who they were and for what they had done in my life. They were wonderful parents, and I will always be grateful for the positive qualities and values they passed on to me. My mother was my everything. I never had a better and more reliable friend.

There's no instructional guide on how to deal with the death of your parents. I hope my parents can see who



I am looking forward to the development of the JRMC Cancer Care Center in Jamestown, N.D. and looking forward to being a part of the campaign planning committee.



Volunteer Connection SOCIAL INTERACTIONS IMPROVE HEALTH

hanks to advances in technology and websites like Facebook, the world is more connected than ever. We know the weather forecast for China, what our old high school friends are up to and news spreads in the blink of an eye. However, while we use technology to glean quickly what's happening around us, we have become disconnected from who's around us. More and more of our daily interactions happen through a screen rather than with a warm-blooded human. While technology is amazing, it certainly cannot replace the impact of actual human connection.

It turns, out our health depends on human contact. Studies from the University of Rochester School of Medicine found that human interaction has real health benefits. Social interactions can help reduce blood pressure, lower risk of cardiovascular disease and even lessen the possibility of conditions like Alzheimer's and depression. Social interaction within a healthcare facility can lower stress and anxiety and can even have a positive effect on medical outcomes. As far as overall health goes, social interactions rank up there with a healthy diet and exercise.

While science backs us up, it isn't difficult to see the importance of real human contact. It is through this real human contact that we can make a difference in the lives of one another. Sure, we can send a text or "like" a picture, but what about holding a hand, dialing the phone or even looking another person in the eye. Actions like these make a difference in the lives of others, and it's these acts that the volunteers at JRMC are doing every day. Whether they are guiding a nervous patient to the surgery center, calling a home-bound member of the community to say hello or helping a proud new brother pick out the perfect gift for his new baby sister; JRMC volunteers are making those important human connections every day.

One service, in particular, is focused primarily on offering a warm, and sometimes lifesaving, human connection. Telecare is a free service that has been provided by the JRMC Auxiliary since 1973 and provides daily phone calls to members of the community who may live alone or don't have many opportunities for social interactions. The Telecare volunteers know the calls that they make are the difference in the lives of their clients. They recognize the importance of human interactions and pride themselves on being a lifeline for isolated members of the community.

Jeannette Srozinski, the chairperson of the program, says, "The calls make the clients feel secure. They know someone is checking on them. We make sure they took their medication or ate breakfast, but they start to feel like friends or family. There is a real connection." Jeannette knows the Telecare volunteers are making a difference by reaching out, and the same goes for all JRMC volunteers. Whether they are holding a hand or delivering a balloon, they provide an important, warm and human connection; and with this regard, they become the difference in the lives of those they serve.
